SAN JUAN COUNTY BOARD OF COMMISSIONERS REGULAR MEETING WEDNESDAY, FEBRUARY 8, 2023 AT 8:30 A.M.

Call to Order: The meeting was called to order by Chairman Pro-Tem Scott Fetchenhier. Present were Commissioners Pete Maisel and Austin Lashley (via Zoom), County Attorney Dennis Golbricht and Administrator William Tookey.

San Miguel County Administrator Mike Bordogna presented to County Administrator Tookey the Association of Colorado County Administrators' Lifetime Achievement Award.

Payment of Bills: Commissioner Maisel moved to authorize payment of the warrants as presented. Commissioner Lashley seconded the motion. The motion passed unanimous.

Minutes: Commissioner Maisel moved to approve the minutes of January 11, 2023 as presented. Commissioner Lashley seconded the motion. The motion passed unanimously.

Commissioner Lashley moved to approve the minutes of January 25 as presented. Commissioner Maisel seconded the motion. The motion passed unanimously.

Public Health Director Becky Joyce was present to provide the Commissioners with an update and to explain the various grants that Public Health have received.

A Public Hearing was held to receive comment concerning the Sketch Plan Improvement Permit Application for the proposed Careaga cabin and associated improvements on the Sandusky Lode on CR 99. Lisa Adair explained the proposed project. The applicant was represented by Chris Clemmons and Aaron Careaga. Upon completion of the Public Hearing Commissioner Lashley moved to approve the Sketch Plan application with the conditions as recommended by staff and the Planning Commission and to include the additional condition that a Cumulative Impact Report be included in future submittals and that minimal impact to the sight be allowed for test holes. Commissioner Maisel seconded the motion. The motion passed unanimously. If the project is not approved the minimal exploratory earthwork necessary for completing the application process must be reclaimed.

Assessor Kim Buck was present to request that the County enter into an agreement with Sidwell GIS Professional Services not to exceed \$10,000. Commissioner Kuhlman moved to approve the agreement as presented. Commissioner Lashley seconded the motion. The motion passed unanimously.

San Juan Basin Public Health Executive Director Liane Jollon, Environmental Health Director Brian Devine, Prevention & Population Health Director Kalisha Crossland and Chief Strategy Officer Chandler Griffen were present to discuss the current services the Basin Health provides to San Juan County. There was some discussion as to what will happen to these services when Basin Health disbands. It was the consensus of the Commissioners to send a letter to the La Plata County Commissioners to raise the question.

Administrator Tookey presented the Commissioners with the December 2022 Financial Report for their review. Commissioner Maisel moved to approve the Financial Report as presented. Commissioner Lashley seconded the motion. The motion passes unanimously.

MEMORANDUM

TO: San Juan County Commissioners

FR: William A. Tookey RE: SALES TAXES

San Juan County currently collects a 4% countywide sales tax. The County first began collecting a 1% sales tax in 1984. The Town of Silverton was planning on increasing their sales tax from 3% to 4%. At that time the maximum allowable sales tax was 7%. With the State at 3% and the Town at 4% that would have prohibited San Juan County from collecting any sales tax. In 1983 the Town and County agreed to pursue a 1% countywide sales tax with the Town receiving the revenues collected within the Town limits and the County receiving the revenues collected in the unincorporated portion of the County. This provided the Town with the additional sales tax revenue that it needed and provided the County with some sales tax revenue. In 1994 the Town suggested that the County increase the countywide sales tax to 4% and the Town would rescind their current 3% sales tax provided that the Town continue to receive all sales tax collected within the Town boundary and that the County receive everything in the unincorporated portion of the County. The County was facing a financial hardship do to the mine closure. The voters approved the ballot question for a 4% countywide sales tax and the Town and County have been sharing that 4% since 1995.

The Town of Silverton has since added an additional 1% Town only sales tax and the County has increased the countywide sales tax by 2.5 percent for Emergency Services and Public Safety. In 2019 as a result of State Statute and a Supreme Court Ruling known as the Wayfair Decision, the State of Colorado began collecting sales tax from businesses who's only presence was via the internet. This increased both the Town and County sales tax revenues.

The attached graph shows the 4% County Sales Tax collected from 2000 to 2022. It also shows the sales tax adjusted for inflation. The inflation adjustment is based on the national CPI. These numbers reflect when the sales tax was collected by the vendor. The County actually receives payment from the State two months later. In 2000 the sales tax collected was \$117,027. In 2022 it was \$310,801 showing an increase of \$193,774. But when adjusted for inflation the sales tax for 2022 was \$183,373 or an increase of \$66,346. If you decrease the total sales tax in 2022 by the \$89,269 in remote sales tax, you see an annual decrease of \$22,923.

When you look at the County Sales Tax graph you will notice that when the numbers are adjusted for inflation only the year 2002 exceeded the year 2000 until 2020, 2021 and 2022 showed positive increases in large part to the collection of the remote sales tax.

Also included is a pie chart that shows the County's sales tax monthly breakdown from 1999-2022.

Upon voter approval the County began collecting a 1% countywide sales tax specifically for Emergency Services and Public Safety. The voters were asked to increase the Emergency

Service/Public Safety sales tax by an additional 1.5%. As a result of a successful election the County began collecting a 2.5% in 2018.

Since 2018 the Emergency Services Sales Tax has increased from \$567,733 to \$999,654 in 2022. This is an annual increase of \$431,921. When adjusted for inflation the sales tax total for 2022 equaled \$789,727 or an increase of \$209,927. If you decrease the inflation adjusted total for 2022 by the \$144,731 collected in remote sales tax the increase between 2018 and 2022 is \$65,196. The total amount of sales tax collected for Emergency Services and Public Safety in the 10 years since it began is \$4,904,403.

The County also collects a 2% Lodging Tax from all lodging establishments including vacation rentals and RV Parks. Through 2022 the Lodging Tax could only be used for the marketing and promotion of San Juan County as determined by State Statute and the election language that approved the Lodging Tax. A change was made in State Statute that would allow for additional uses with the Lodging Tax. San Juan County placed a measure on the 2022 Ballot asking the voters if they would allow 40% of the Lodging Tax to continue to be used for marketing and promotion; 40% to be used for workforce housing and 20% to be used to enhance the visitor's experience. The ballot measure passed. Based upon the \$175,000 collected in Lodging Tax in 2022 marketing and promotion would receive \$70,000; workforce housing would receive \$70,000 and visitor's enhancement would receive \$35,000.

The County received a total of \$56,682 in 2000 for the Lodging Tax. In 2022 the Lodging Tax annual total was \$175,019 for an increase from 2000 in the amount of \$118,337. When the 2022 annual total is adjusted for inflation the amount is \$103,261 or an increase from 2000 of \$46,579. The County Lodging Tax peaked in 2021 at \$205,604. I believe this was primarily a result of the COVID 19 Pandemic when people were limited to where and how they travelled, and many were seeking remote outdoor locations.

The Town of Silverton received \$457,431 in sales tax from 2000. In 2022 the Town received \$1,282,662 for an increase from 2000 of \$825,231. When the 2022 total is adjusted for inflation the amount is \$756,771 for an annual increase from 2000 of \$299,340. If you reduce the inflation adjusted total by the \$140,384 collected in remote sales tax the increase is \$158,956.

The Town's sales tax decreased from 2021 to 2022 in the amount of \$30,521. However, when these numbers are adjusted for inflation and the remote sales tax is removed the decrease equals \$68.553. There were several contributing factors that probably played a role in the sales tax decrease. The primary factor is probably that COVID Pandemic heavily impacted the 2021 record sales. 2022 the world was reopening, and travelers had more opportunities. Other factors included inflation and specifically high fuel prices, a rainy summer, and the Town's prohibition on OHVs. When adjusting for inflation 2022 was still far above any yea except for 2021.

Additional graphs and charts concerning the Town's Sales Tax include a breakdown in "summer" vs. "winter" months. May, June, July, August, September and October are included in

the summer months and January, February, March, April, November and December are included in the winter months. The graph covers the time period from 1988 to 2022.


Also included are three pie charts that breakdown the Town's sales tax by month. The charts include the monthly breakdown of the total Town Sales Tax from 1998-2022 and specifically for the years of 1988 and 2022.

Sales Tax is a primary revenue for both the Town and County. Events within and outside of our control can have an impact. The Missionary Ridge Fire June 9 2002 to July 15 2002 causing the train to cease operations. August 5, 2015 the Gold King Mine was breached creating an environmental concern and worldwide negative publicity. The 416 Fire June 1, 2018 to July 31, 2018 causing Highway 550 south to be closed and causing the train to cease operations. The Ice Fire October 19, 2020 to Oct 26, 2020 closing the South Mineral and Ice Lake areas. The COVID Pandemic caused the Town and businesses to be shut down in March of 2020 in 2021 the impacts of COVID caused the Town and backcountry to be overwhelmed with visitors.


There have been mudslides and flash floods that have caused the train to stop operations. There have been snowstorms and avalanches that close Highway 550. Rockslides on 550 north caused the highway to be closed for an extended period of time. San Miguel Power Association fire mitigation and new transmission lines cause 550 north to be closed. Road construction projects can cause the highway to be closed for extended time periods. Allowing OHVs within the Town limits or prohibiting OHVs within the Town limits impact sales tax. Opening backcountry roads and the snowpack that limits the use of the backcountry impact sales tax.

It is critical for the operation of the Town and County Governments and Emergency Services that we maintain a healthy sales tax.


SAN JUAN COUNTY 4% SALES TAX 2000-2022




SAN JUAN COUNTY 4% SALES TAX 2000-2022




SAN JUAN COUNTY 4% MONTHLY SALES TAX 1999-2022




EMERGENCY SERVICES SALES TAX 2013-2022




EMERGENCY SERVICES SALES TAX 2013-2022




SAN JUAN COUNTY LODGING TAX 2000-2022




TOWN OF SILVERTON 4% SALES TAX 2000-2022




TOWN OF SILVERTON 4% SALES TAX 2000-2022




TOWN OF SILVERTON 4% SALES TAX SUMMER/WINTER




TOWN OF SILVERTON 4% MONTHLY SALES TAX 1988-2022
