


 \succ POSSIBLE ACTIONS (2) **ONE-WAY TRAFFIC** SPEED BUMPS **REDUCE SPEED PROVIDE DUST CONTROL** INSTALL A BARRACADE ON CR 22 BETWEEN ARRASTRA GULCH AND HOWARDSVILLE ALLOWING FOR MOTORIZED USE BUT NOT ALLOWING THROUGH TRAFFIC
